#### 7. Other projects and responsibilities:

- b. Football Posts Twyn-yr-Odyn VOG confirmed availability with 3-4 weeks lead time for delivery and installation. Proposed Cllr R Godfrey, Seconded Cllr P Freeman with unanimous vote in favour. Clerk to place order.
- c. WRAC update Cllr P Freeman advised that Parc Dyffryn solar farm is ongoing but delayed possibly up to a year. Council informed of an increase in fly tipping in the Wenvoe area. Cllr S Milliner offered to look at legislation to the installation of trapper cameras ongoing.
- d. Repair Café Wales following discussions, Chair to provide Council with breakdown of full costs to implement and running costs postponed to May 2023.
- e. Independent Remuneration Panel for Wales Annual Report Chair & Vice Chair to take allowance, Councillors to email Clerk to confirm whether they wish to take allowance or not.
- f. Replacement Memorial Bench MOP to confirm that replacement bench to be one time donation, bench to added to Wenvoe Community Council insurance.
- g. Scout Post & Sign
  - 1. Sign 4' x 2' to advertise Scouts groups to be financed and installed by Wenvoe Scouts. Proposed Cllr P Freeman, Seconded Cllr R Jervis Scouts to liaise with Council re placement of sign to be agreed.
  - 2. Scout Post Scouts groups are hopeful that Scout post will go ahead this year. It was agreed that Wenvoe Community Centre be available for this purpose. Proposed Cllr P Freeman, Seconded Cllr R Jervis with unanimous vote in favour.
- h. Boundary Review Cllr M Harvey provided brief history of boundaries previously proposed and that residents didn't wish to change their boundaries. Cllr R Godfrey submitted Petition signed by residents of St Lythans opposing any change to the current boundaries. Chair pointed out that the Boundary Review is a three-phase operation.
