7. Other projects and responsibilities:

- a. Patio Cllr P Gaughan & Cllr R Jervis were praised for the fantastic job in relation to the replacement patio. The next programme of works is to install/implement bollards in front of the Hub/Library building and two disabled bays within the Wenvoe Community Centre carpark, previously approved by Council. Cllr R Jervis proposed any garden furniture purchased by Wenvoe Library Limited be stored in one of the outbuildings. Seconded by Cllr P Freeman.
- b. Blinds Small Meeting Room make enquiries for provision of privacy film and/or blinds to all windows. Cllr J Williams (Chair) to action ongoing.
- c. Football Posts Twyn-yr-Odyn installed by Vale of Glamorgan, works completed.
- d. WRAC update Chair thanked Cllr P Freeman for providing minutes of meeting held Thursday 1 June 2023. Cllr P Freeman informed Council that expanding of The Great Glamorgan Way Bridleway was an Order of Vale of Glamorgan. Currently all solar farm applications are delayed and could take up to 5 years.

- e. Boundary Review to note the view of WCC to the Commissions. Await Phase 2 reminder no update.
- f. 5-year development plan ongoing.
 - i. Redecoration/Repair to full interior of Wenvoe Community Centre to include wooden floor in main hall. One Quotation received to date.
 - ii. Firesafe cabinet to store historical documents, minutes of meetings and burial registers.
 - iii. Burglar, Carbon Monoxide, Fire & Smoke Alarms
 - iv. Wenvoe Community Council to liaise with all areas within Wenvoe to enquire as to whether there are any requirements/additions, i.e., Mapping engagement report 'what do you need?'
 - v. Fascia boards replacement to Wenvoe Community Centre.

- i. Training Plan Recommendation that all new Councillors attend training course 'New Councillor Induction' an online training course offered by One Voice Wales.
- j. Scout sign Council decided the sign proposed by Scout Group representative unsuitable to be placed within the front garden of Wenvoe Community Centre. Clerk to inform Scouts representative.
- k. Refurbishment Storage Outbuildings ongoing.
- I. Wenvoe Wheelers hall hire Council agreed payment to be made in relation to hall hire.

8. Any matters the Chairman decide are urgent:

- a. Following Vale of Glamorgan Alps Depot stopping the provision of recycling products, the outbuildings need to be renovated to prevent damp and provide clean storage before Wenvoe Community Centre and the Hub/Library to be able to offer this service to members of the public.
- b. Tree located within grounds to the rear of the Hub/Library. Following inspection by members of the Council it was agreed that the tree to be discussed appeared healthy, the tree to be 'pruned' where it is overhanging neighbouring properties. Clerk to action.
- c. Recently burnt conifer hedge intruding onto Wenvoe Community Council car park from neighbouring property. After lengthy discussion it was agreed that the owner of the hedge be contacted by letter to advise that Council believe it was their responsibility to carry out any remedial works to remove all overgrown branches intruding onto Council premises. Clerk to action.

9. Health & Safety matters:

Fire door and main hall door glass, fire exit in kitchen to be taken to Health & Safety Committee.

- d. Cllr R Sexton advised Council that new signs had been put up in Wenvoe. Cllr R Sexton to submit photographs to Clerk to be reported to the Vale of Glamorgan, with a copy to Cllr P Freeman for WRAC.
